DIRECTOR'S REPORT

Ms. Kohles proposed the library adopt the Suffolk County Library's common voting date of Tuesday, April 2nd, 2024. The alternate date of April 9th, 2024 was agreed upon since Central Islip schools are closed on the prior week and many families may be out of town.

SCLS has proposed a minimal increase this year. As they provide several essential services to the library, Ms. Kohles recommends that we approve their 2024 budget as presented.

E-Book service has increased by 12% this year, which is on the rise as a main source of accessing books.

SCLS has a vacancy for the Islip area. Ms. Kohles has shared the information for the two candidates and provided ballots for trustees who would like to cast their vote.

Ms. Kohles presented an updated Meeting Room Policy for approval, in anticipation of the construction of additional meeting rooms next year.

Ms. Kohles advised the Board of an open invitation for \$175 to the NAACP Gala on Saturday, January 13th. Dunia Mars will attend, and the remaining members will respond via email.
